


#### Dear Colleague:

On behalf of the National Institute on Drug Abuse (NIDA) and the American Psychiatric Association (APA), it is our privilege to welcome you to a special research-based program track—*The Science of Addiction: Translating New Insights Into Better Psychiatric Practice*—during the 160th APA Annual Meeting.

This year's scientific track features compelling lectures on addiction-related topics ranging from the neurobiology of free will to the role of stress and genetics to treatment access. The ongoing collaboration between NIDA and APA, following on 2004's successful scientific track on addiction, will fuel the growing momentum needed to raise awareness of and address emerging issues in addiction and psychiatry.

Science continues to add to this knowledge as studies incorporating genetics, environmental factors, and modern brain imaging technologies are revealing new knowledge about both mental illness and substance abuse disorders. Indeed, understanding the interplay of neurobiology and social-behavioral factors has relevance for drug addiction and mental illness, and highlights the need for practitioners to identify and treat both conditions.

Interactive workshops and symposia will cover gene-environment interactions, along with stress responsivity, obesity and brain imaging, methamphetamine abuse, and promising new approaches to substance abuse treatment. Other sessions will address such vital questions as the directionality of comorbid drug abuse and other psychiatric disorders—which comes first?—and how to meet drug abuse treatment needs in the criminal justice system.

The variety of information presented will offer participants new insights into common risk factors and potential treatments for multiple disorders. We wish to again thank the APA's Council on Addiction Psychiatry for bringing this timely and productive collaborative series to the Annual Meeting.
